In regards to the receipt of the animal listed below, I, the above named foster, agree to provide care including but not limited to: Feed, water, protection from weather, trimming and emergency veterinary care. I also agree that:

- 1) The animal will be properly cared for and will remain the property of Second Time Around Rescue Ranch.
- 2) This animal will not be sold, bartered, loaned, exchanged, or given away. ***If the fostering of this animal is no longer desirable or possible, the animal will be returned to Second Time Around Rescue Ranch.***
- 3) The Second Time Around will be notified within 24 hours of the death or illness of this horse.
- 4) The animal is not to be bred under any circumstances.
- 5) **If at any time the animal is found to be in unsatisfactory condition, or a Second Time Around Rescue Ranch representative feels that the animal is not being properly cared for, a staff member or volunteer may enter any property on which the animal is being maintained and reclaim the animal.**
- 6) Except under extreme circumstances, the foster animal may not be euthanized without the express permission of a staff member of Second Time Around Rescue Ranch.
- 7) Every effort has been made to disclose the history and medical condition of this animal AS WE KNOW IT. These are rescued animals, and generally we have little or no knowledge of

the animal's prior life, medical history, or training. We will communicate everything we know about this animal.

- 8) Second Time Around Rescue Ranch are not liable for any injury to or death of any person or other animal related to the action of this animal once you have received them. Some of the animals are large and powerful animals, and all equine activities carry inherent risks.
- 9) It is understood that this animal is available for adoption while being fostered. If a potential adopter is interested in adopting this animal, Second Time Around Rescue Ranch will notify the foster of this interest. The foster will have first right of refusal, and must notify Second Time Around Rescue Ranch of intention to adopt the foster animal within 48 hours of this notification.
- 10) The foster will be willing to allow potential adopters to view and interact with the animal on the property where the animal is housed. If the foster has concerns or opinions about the potential adopter, the foster agrees to communicate these concerns or opinions to Second Time Around Rescue Ranch staff immediately.
